

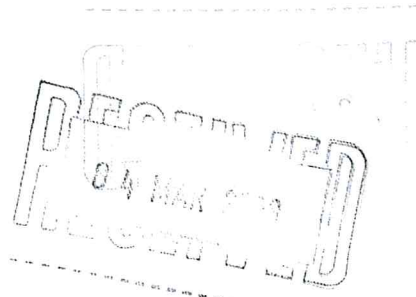

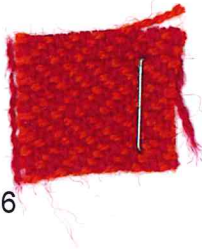

The sample was tested after water soaking in accordance with BS 5651: 1978 clause 4.

Requirements: No part of any hole nor any part of the lowest boundary of any flame shall reach the upper edge or either vertical edge of any specimen, and there shall be no separation of flaming debris.
